User Agreement (Terms of Use)

The Great Body Shop (“Curriculum”) is a comprehensive Health Curriculum provided in print and digital form designed for Pre-K through middle school. The Curriculum and Website are owned and operated by *The Children’s Health Market, Inc.* (“Company”, “we”, “our”, or “us”) and provides licensed users access to health education curriculum and related resources. The purchase of printed material includes a digital license. By purchasing the Curriculum and when accessing the Website, you agree to be bound by these Terms. If you do not agree, you may not use the Curriculum or Website.

1. Eligibility

Use of the Curriculum and Website is limited to individuals who are:

- Authorized by a school, school district, educational institution, or organization that has entered into a licensing agreement with *The Children’s Health Market, Inc.*; or
- Educators or administrators of district have purchased The Great Body Shop Health Curriculum directly; or
- Parents or guardians who have obtained access on behalf of their child through an authorized license.
- **Students are only eligible to use the Site if access has been granted through an authorized district or institutional license.**

2. License and Use of Materials

When you access our Curriculum, we grant you a limited, non-exclusive, non-transferable license to use the materials for non-commercial, educational purposes only.

We offer access to our curriculum and materials under a **1-to-1 paid subscription model**.

This means:

- Each license grants access to **one individual user** (e.g., a student and parent, teacher, or administrator).
- Sharing a license, login credentials, or downloaded materials with other individuals is strictly prohibited.
- Group use requires the purchase of multiple licenses (e.g., for classrooms, organizations, or institutions).

Licenses are **non-transferable, non-sublicensable**, and may be revoked if these terms are violated.

3. Reproduction Restrictions

When you purchase or access our curriculum, we grant you a limited, non-exclusive, non-transferable license to use the materials **for personal or institutional educational use only**, subject to the following restrictions.

Reproduction Policy Exception:

You may **not** reproduce, copy, or distribute any portion of the printed or digital curriculum **except** for pages that are clearly designated as **Worksheets** in the Teacher's Guides.

Worksheets:

- Are clearly labeled as such within the Teacher's Guides.
- May be photocopied or printed **only by the original purchaser or licensed user**.
- May be used solely within the classroom, homeschool, or institution that purchased the materials.
- May not be shared, sold, uploaded, or distributed outside the licensed environment.

All rights not expressly granted in this User Agreement are reserved by Children's Health Market, Inc.

4. Prohibited Uses

Except as specifically permitted above, you may not:

- Copy, scan, digitize, or share any part of the materials (printed or digital).
- Upload our content to any public or shared online platform (e.g., Google Drive, classroom websites, file-sharing sites).
- Share login credentials or digital access with anyone outside your licensed group.
- Resell, sublicense, or create derivative works based on our content.
- Represent our materials as your own or alter them in a way that obscures ownership or branding.
